**P.19 - 06.14 APOLOGIES**

Apologies were received and accepted for Councillor C Stallard Daniels

**P.20 - 06.14 INTERESTS**

Councillor R Yeoman declared a Disclosable Pecuniary interest in Agenda Item 5,10 as a Trustee of Ledbury Cricket Club.  
Councillor A Crowe declared a non-pecuniary interest in agenda item 5,11.

**P.21 - 06.14 PUBLIC PARTICIPATION**

A local resident outlined her objections to proposed waiting restrictions in the town, namely those in Worcester Road and off Bye Street. She felt they were unnecessary and would have a detrimental effect on local businesses and devalue properties in the area.

Mr Matthew Erlich, representing Ledbury Cricket Club, spoke in support of the planning application P141651/O (refer P.23-06.14, 10) He explained that the applicants had offered the Cricket Club a re-location package to move from the land behind the Full Pitcher, currently on a short-term rolling lease, to a freehold site near the Ross Road Playing fields. He outlined the opportunities and benefits that this would give to the long term development of the Cricket Club. The main points being:

- The move to a freehold site would guarantee the future of the Club
- New brick built pavilion, wickets, junior nets and practice nets
- Up to date facilities compliant with disability access standards
- Opportunity to re-start junior section and U16 football in winter

#### **P.25 - 06.14 APPEAL DECISION**

Members were advised of the following appeal decision by the Planning Inspectorate

Appeal Ref.: APP/W1850/D/14/2217279

Site: 5 Larkrise, Knapp lane, Ledbury, HR8 1AN

Description: The Appeal is against the decision of Herefordshire Council to refuse planning application ref P132945/FH for a 1.8m high fence and garden shed, loglap 1.8 x 2.4m, and closure of existing vehicular access.

**Inspector's decision: The appeal is dismissed.**

#### **P.26 - 06.14 WORKING PARTY REPORTS**

Neighbourhood Plan

1. Members received a report from the Neighbourhood Plan Working Party meeting held on 3<sup>rd</sup> June 2014, copies having been circulated.

2. The Chairman advised that due to insufficient time between meetings, the report from the Neighbourhood Plan Working Party meeting held on 23<sup>rd</sup> June 2014 had not been completed in time for circulation at the meeting. The report will be presented at the next meeting.

#### **P.27 - 06.14 DISABLED PARKING**

Councillor Francis advised the meeting that he had been approached by a user of a powered wheelchair who had queried where he could park his vehicle. Councillor Crowe said that users of powered wheelchairs and mobility scooters normally park outside shops or sometimes take them inside if space allowed. Councillor Durham, himself a user of a powered wheelchair, advised that he had not experienced any difficulties parking in the town centre.

The Clerk provided information obtained from the .GOV.UK website pertaining to parking – section 45 of the 'Rules for users of powered wheelchairs and mobility scooters' states:

*“All normal parking restrictions should be observed. Your vehicle should not be left unattended if it causes an obstruction to other pedestrians - especially those in wheelchairs. Parking concessions provided under the Blue Badge scheme (see 'Other information') will apply to those vehicles displaying a valid badge”.*

**RESOLVED: That this be noted.**

**P.28 - 06.14 TOWN CENTRE SIGNAGE**

Councillor Eager raised his concerns over poor car parking signage in the town centre. He felt that this was contributing factor to an apparent decline in visitor numbers to the town, as motorists, unable to easily locate the car parks, were simply driving on through to other destinations. Councillor Harvey advised that she had raised the matter with the Parking Services Manager at Herefordshire Council and that he was awaiting a list from the Town Council identifying where signs should be improved/sited. In order to cut down on street clutter it was suggested that consideration could be given to painted directional car parking signage on the highway.

**RESOLVED: That Councillors Barnes, Conway and Eager compile a list for submission to Herefordshire Council.**
