**P.52 - 11.14 APOLOGIES**

Apologies were received and accepted from Councillors K Francis and C Stallard Daniels.

**P.53 - 11.14 INTERESTS**

There were no interests declared at this point in the meeting.

**P.54 - 11.14 PUBLIC PARTICIPATION**

Five local residents spoke of their objections to Planning Application No P143028/F (refer P142986/F)

The main issues raised were: increased traffic movements; odours from chicken waste; lack of local consultation; size and scale of broiler units and impact upon the AONB; effect on tourism and local economy.

A local resident voiced his concerns relating to Planning Application P142986/F (refer P142986/F, 2), in that the orientation and positioning of the proposed dwelling would cause privacy and overlooking issues.

- a) Unsuitable development in an AONB.
  - b) Inappropriate setting and the landscaping does little to minimise the visual impact of the development.
  - c) danger of pollution of the neighbouring water course.
  - d) traffic movements and odour levels would be unacceptable to Ledbury residents and others in the surrounding area.
  - e) NPPF 112 designates this land as prime agricultural land and it should be used as such.
  - f) the two additional jobs created on the site will do little mitigate potential job losses elsewhere in the area

The diversion is proposed by Haygrove Ltd at Redbank to Public Footpath LR10 upon the section lying north of Lilly Hall Lane and east of Falcon Lane.
