## NOTICE OF VACANCY

### Ledbury [Ledbury North] Parish Ward

**NOTICE IS HEREBY GIVEN** that a casual vacancy is deemed to have occurred in the office of Councillor for the **Ledbury [Ledbury North] Parish Ward** following the **resignation of Elaine Louise Fieldhouse**.

Rule 5 of the Local Elections (Parishes and Communities) (England and Wales) Rules 2006, provides that on a casual vacancy occurring in the office of **Parish Ward** councillor, an election to fill the vacancy shall be held if within fourteen days\* after the date of this notice (i.e. no later than **Wednesday, 20th June 2018**) has been given in accordance with section 87(2) of the Local Government Act 1972, notice in writing of a request for such an election has been given to the proper officer of the council of the district within which the **Parish Ward** is situate by **TEN** electors for the **Parish Ward**.

If a request for an election is not received by the above deadline then **Ledbury Town Council** will co-opt a person to fill the vacancy as soon as practicable in accordance with the Local Elections (Parishes and Communities) Rules 1986.

If there is an election, it will take place not later than **Wednesday, 22nd August 2018**.
